

**ORDER OF COURT**

Attached to this order is a pretrial calendar that notifies each attorney of an exact date and time to appear in this Court for a pretrial conference in preparation for the next term of jury trials. Each attorney shall immediately read and be governed by Uniform Court Rules 7.1 and 7.2 which outline the pretrial procedure used in the Courts of the Alapaha Judicial Circuit. All pretrial conferences shall be attended by the attorneys who will actually try the action. Attorneys for the Plaintiff shall prepare a proposed pretrial order and submit it to opposing counsel and all attorneys in the case shall meet and confer for the purpose of perfecting such order prior to the pretrial conference before this Court. A written proposed pretrial order is substantially the form required by the rules shall be presented to the Judge at the commencement of the pretrial conference (See Uniform Court Rule 7.2). This Court will place no case on the jury trial docket unless a pretrial order has been prepared and approved by the presiding Judge or unless the Judge decides no pretrial order is necessary. Failure of counsel to appear at the pretrial conference without legal excuse or to present a proposed pretrial order shall authorize the Court to remove the action from any trial calendar, enter such pretrial order as the Court shall deem appropriate, or to impose any other appropriate sanction. A copy of this order shall be mailed by the Clerk of Court to each attorney who has a case on the pretrial conference calendar and to any individuals who have cases on the calendar and are not represented by counsel.
